Grading the student's learning outcome achievements is carried out according to the following steps:

- During the realization of learning outcomes for a given course/module and after its conclusion, through the verification of learning outcomes carried out for each student by the course instructor/examiner;
- after realizing the program for a given course/module, through the verification of learning outcomes carried out by the course/module instructor/coordinator;
- after concluding each semester, through the verification of learning outcomes achieved by the students of a given program;
- during the diploma exam, through the verification of learning outcomes carried out for each student by the examiners taking part in the diploma exam;
- in an ongoing manner, through the assessment of learning outcome realization by appointed course observers;
- after the conclusion of each study program, through the verification of learning outcome according to quantitative indices as well as through monitoring the graduates' careers and job market performance.
